

# JFO's AND ALL MANKIND!

Dr. Fred Hoyle, one of the world's foremost astro-

"I think we are property."

"I say we belong to something. That once upon a time, this earth was a no-man's-land, that other worlds explored and colonized here, and fought among themselves for possession, but now it's owned by something. And that something owns this earth and all others (have been) warned

Those are the devastating words of Charles Fort, the famed compiler of data concerning odd phenomena, worldwide mysteries and UFOs.

Many of us have read his words before, but have we taken them seriously enough? And yet, if UFO reports are analyzed-or reevaluated-in a new way, there is almost frightening evidence that we are somebody's "property," that earth has been visited, observed, and controlled by beings in flying saucers for untold ages.

In fact, this can be the only logical reason one can think of for the endless parades of UFOs swarming around our world, century after century. If their mission were merely to study earth out of scientific curiosity, their job would


have been accomplished in a few centuries and the UFOs would have left in ancient times.

Therefore, why are they still around in the present? Could their interest be much deeper—an interest in *personal property?* Not only earth itself but you and me and the other 3 1/2 billion people around the world. And with this astounding conclusion UFOs will now mean Unidentified Flying Owners.

But who takes Fort seriously?

One of the world's most famous scientists does. In fact, he goes Fort one better and presents an even more grim and mind-staggering picture. The scientist is Dr. Fred Hoyle of England, probably the top rated astrophysicist in the world, and author of the Steady State theory of the universe.

At a press conference on May 10, 1971, (according to the *National Bulletin*), Hoyle shocked everyone by saying: "Human beings are simply pawns in the games of alien minds that control our



every move. They are everywhere, in the sky, on the sea, and on the earth. They have been here since the beginning of time. . ." (Italics have been added for emphasis.)

Hoyle avoids using the terms "UFO" or "flying saucer," but his meaning is obvious.

If you think Hoyle is a "maverick" scientist whose ideas are not shared by his colleagues, he reveals that a large part of the scientific establishment is convinced that other intelligences exist on this planet and they have kept their secret belief from the public.

ot only scientists but all the world's governments are sitting on this volcano. "The only reason I called this press conference," stated Hoyle, "is that no government in the world would release this information. They fear panic among the people. And think that if the people know that some intelligent force is controlling them, they will no longer listen to them."

And that could explain the whole baffling riddle of U.S.A.F. secrecy regarding flying saucers, the "white-washing" by the Condon Report, and the constant denials by high officials that anything unusual is being seen in the skies, even in the face

of overwhelming evidence.

As strange as it may seem, an internationally known scientist has explained the mysterious UFOs in a wilder way than any UFOlogist or flying saucer investigator ever dared. In private, most of sciencedom is simply repeating Charles Fort's words—we are property.

What are the unknown aliens doing with this living property? In what way are they benefiting from us, or exploiting us? We can dismiss Fort's private conclusion, that we are "cattle" being raised on a huge world-sized "ranch" for the same purposes we maintain ranches. He also stated we are "fished for" in subtle ways. But if humans were delectable "food" to the saucermen, then surely millions upon millions of us would be whisked away to their tables to delight their gourmets. Police records of missing persons do show that people annually disappear atarather astonishing rate—several thousand a year in such big cities as London and New York. But that is still a drop in the bucket compared to earth's total population.

hose who apparently "vanish from earth" must be taken away by UFOs for some other purpose than stocking their home-world larders. So, the saucermen are not going to solve our population explosion problem for us. In fact, they may actually be responsible for the enormous fertility of the human race. And if not that, why else are they here?

All sorts of guesses can and have been made on this dilemma. Some feel they are here to "colonize" us, or to help us achieve a better civilization, prevent a nuclear war, or other such noble aims.

But one very probable assumption can be made—their thinking processes, motives, and aims are so totally alien to us that we simply cannot equate them in *any* terms we know.

Dr. Fred Hoyle concurs in this when he says, "They (the aliens) are so different from what we know that to try and describe them in language that everyone would understand would be impossible." He clarifies this further and each time he says something more shocking than before. Briefly, our "owners" or "landlords" are not merely from another world but another universe, probably one with five dimensions. This is not wild conjecture, he says, but has been worked out in scientific papers circulated only among scientists. Their laws of chemistry and physics are completely different from ours and they can easily break the time and space "barriers" that restrict us and can travel anywhere in the universe in seconds.

Dr. Hoyle cautiously refrains from using the words "UFOs" or "flying saucers" in order to keep from putting the stamp of "authority" on the lunatic fringe of UFOlogy. But he makes it quite plain that the aliens are around us all the time when he says, "Our whole life and the complete existence of this universe are at the whim of these creatures that hold fantastic mental powers over us."

The last falls exactly in line with all the basic theories in UFOlogy—the men-in-black harassers of UFO investigators and witnesses, the contactees and "hypnotic" illusions, and the cases of people's lives being "manipulated" after a saucer sighting.

Dr. Hoyle probably couldn't openly say UFOs because the British government might immediately clamp down on his startling revelations.

Therefore, we can say what Fred Hoyle couldn't—that the alien owners are all about us in flying saucers. Yet they remain as aloof and mystical as they can because they simply cannot explain their "motivations" for running our world.

Astonishingly, Dr. Hoyle corroborates almost every theory previously put forth by UFO researchers. For instance, he pointed out that the "alien intelligences have probably controlled our complete evolution.."

his of course has been the theme of several books on UFOs—by Brinsley le Poer Trench, Erich von Daniken, Max Flindt and others—in which the star-men or sky-people of legend came down and manipulated the genes of early hominids (man-apes) to produce the "hybrid" human species, which is far more advanced than the anthropoids.

This covers the big hole in the Theory of Evolution—mankind's enormous brain. By natural selection and the struggle of the species, it would have taken at least 50 million years in the agonizingly slow process of evolution to triple the brain size of chimps and other apes. Yet this occurred in only one or two million years according to anthropologists. The stubborn evolutionists will not admit that this gross anomaly casts doubt on their theory.

The "genetic experiments" of the aliens might have followed this pattern. They came to earth many millions of years ago and found that the hominids or man-like apes held the most promise for achieving a thinking brain. Then they either interbred with them or manipulated their genetic codes to produce modern man.

There are other peculiarities in the evolutionary theory. Why did life (outside of primitive single-celled bacteria) first appear on earth as late as 500 million years ago, in (Continued on page 88)

Proposed solutions range from an outright ban on all dumping of wastes into the sea by 1975, as proposed by Senator Nelson, to the setting of rigid controls where dumping is deemed necessary. Nelson, an ardent conservationist, would go a step further. "We must prohibit any new activity—from building offshore jetports to the drilling of additional oil wells—until we set tough new controls to avoid the chaos and destruction in the sea that is everywhere."

Other experts, such as Dr. Lowenstein, insist that even the most rigid legislation passed by Congress is still not enough. The problem is not only national, they point out, but *international*.

"During the next 10 years there will be a tenfold increase in the production of radioactive wastes," Lowenstein told the Bordeaux conference, "but as yet there are no international agreements limiting the disposal of these wastes into the oceans."

After years of wrangling over the issue, 63 nations, led by the United States and

Russia, signed a historic treaty banning nuclear weapons from the ocean floor in a widely heralded ceremony on Feb. 10, 1971. The treaty was indeed a major step; a radiant President Nixon, at the Washington part of the ceremony, called the seabed "man's last frontier on earth," and added: "By signing this treaty, we have pledged to seek its promise and remove its peril."

But the treaty, as important as it is, remains severely limited. It covers only international waters, those vast areas of the sea starting three to 12 miles out from the coastlines of signatory nations (Ecuador and Peru, who insist that their boundaries extend 200 miles, refused to sign.) It does not cover the area where radioactive peril is the greatest—the coastal regions—nor does it regulate mobile weapons like those carried on submarines.

"Many other nations have far less rigorous controls on nuclear wastes than we do," Dr. Lowenstein points out. "It cannot be expected that developing nations, viewed as possible customers for nuclear power plants exported by the advanced nations, will adhere to waste disposal techniques which are expensive and require a high level of technology."

The prospects for cleaner oceans, in other words, appear pretty grim. When at least some radiation can be found in any 50-gallon bucket of seawater plucked from any part of the ocean, no matter how far from the nearest land, that's a fair indication that Stanford ecologist Ehrlich may be right in his prophecy that the seas—and mankind—are inevitably doomed.

And if Ehrlich is right, what the hell good are 130-knot, nuclear-powered, ocean-crossing skimmer boats, huge recreation complexes planted in mid-ocean, or nuclear power plants churning out millions of kilowatts on every street corner?

"Citizens must take a stand now for their friend, the sea," Senator Nelson succinctly stated. "They must use every device within the political process to see that it is protected."

Even coming from a vote-wise politician, that seems to make a lot of sense.

the Cambrian Era? Why is the Pre-Cambrian era, which stretches back for 1.5 billion years, void of fossils? Did the UFOs come to earth 500 million years ago and "seed" earth with life?

Secondly, desert fauna and flora have no evolutionary history and have left no fossils showing a gradual scale of change. They appeared suddenly on earth, out of nowhere. Again, this suggests that the aliens imported desert species of animals and plants for our barren areas.

These and other irregularities in the evolution theory should warn us that all is not right, that something tampered with life on earth long ago—with a purpose. The rising number of present-day sexual-contact cases, of earth people and saucer people, hints at mankind being a hybrid product between alien sires and subhuman subjects. In which case, man did not "descend" but ascended from the apes.

Their probable motivation for interbreeding was brilliantly put by Brad Steiger and Joan Whritenour in their book, Flying Saucers Are Hostile—"What easier way to gain a world than through a superior race operating from within man's own species?"

Which may be exactly how our Unidentified Flying Owners got to be owners.

Another burning question has recently come up that has stumped archeologists. Though *Homo sapiens* appeared some 50,000 years ago as an established species, why did civilization appear suddenly only five or 6,000 years ago? Dr. Carl Sagan has offered one solution by suggesting that the ancient Akkadian (Sumerian) legends are not myths but state the truth. Those legends tell of skymen coming down in "metal eggs" and showing the prehistoric human savages how to plant crops, make crude instruments, and devise writing.

Helping to launch civilization on earth seems to make our alien owners "benefi-88 SAGA cent." However, we'll see that all their various deeds cannot be classified "good" or "bad." They appear to be both. This paradox simply comes out of the fact that we can't even conceive of their true motives, or their "grand plan." The bits and pieces of the jigsaw puzzle won't fit into any pattern recognizable to us. Hoyle makes this rather cynically clear when he adds, "All of what man has built and become was done because of the tinkering of these intelligent forces."

This dispels once and for all any silly notion that the aliens are "scouting" our world and ready to "conquer" us. That infantile viewpoint is immediately destroyed by the thought of their capabilities. With their remarkable flying saucers (which the U.S.A.F. cannot prevent from constantly violating our air-space), they could easily have conquered earth at any moment they chose in the past 10,000

Why conquer us when they already own us? Hoyle's words and many other clues indicate that the UFOwners came to earth before mankind existed and took over ownership then.

We should now warn you that as we go on, Hoyle's concept (or truth?) will knock you off your pins more and more. For example, he makes another fantastic statement of great significance—"They seem to be totally free of any physical restrictions, such as bodies. They are like pure thought and can be anywhere at any time they please." He also mentions that "the weirdest thing about it is that at times they actually appear in physical forms."

If you are a regular reader of SAGA, you will notice that this coincides exactly with the description of the SIs (Space Intelligences) given by Ted Owens, the PK-Man.

"In this way," Hoyle concludes, "they have been responsible for almost all the

legends in different countries, which are scoffed at today."

This agrees precisely with the theme of Dr. Jacques Vallee's recent book, Passport to Magonia. Vallee was one of the

first scientists to accept the reality of saucers and investigate them. He at first favored the straightforward interstellar theory of spaceships of extraterrestrials visiting earth, but then did a surprising turnabout in the above book, wherein he traces the similarity of modern UFO sightings and many legends of the past.

This also falls in line with the slowly evolving viewpoints of top UFO researchers, including John A. Keel. In his book, UFOs: Operation Trojan Horse, Keel takes a different view, that our "owners" are not aliens from anywhere but are "ultraterrestrials" who have shared earth with us since life began. The "sharing" is about one percent by humans and 99 percent by UT control (as to who runs things), lending a rather sinister aspect to the whole situation.

Dr. Fred Hoyle makes the equally chilling statement that, "They have been here since the beginning of time and control nearly everything we do. And to this day they continue to control our minds."

Keel goes at this in another fashion and proclaims that all or most UFO phenomena are psychic phenomena. Hypnotic visions of contactees, sightings of "ghostly" saucers that fade away inexplicably, the lofty "messages" planted in witnesses' minds, the poltergeist activity of ten associated with hovering saucers—all are cases of mental manipulations by creatures of super-intelligence who posses fantastic psychic powers.

This super-intelligence, and their secret control of us, was also highlighted by the famed Allende case of Dr. Morris K. Jessup, and the marginal notations in a copy of his book, Case for the UFOs, mailed anonymously to the Navy and its department investigating UFOs.

The strange notations were made by three individuals commenting on the book's contents with the apparent viewpoint of aliens. Where Jessup's book discusses the possibility of ancient civilizations on earth before the present one, the notation says quite sarcastically:

"Einstein wasn't alive then, but the natural functions of our universe and this planet worked quite well without him."

Another notation is even more significant, relating to Carl Sagan's suggestion mentioned earlier. The notation said—"What inspiration caused man to become man by starting to use tools? Whence came the idea? Science says 'of necessity,' but the same necessity exists for apes... even now."

In fact, it again exposes the weakness of the classic evolution theory which tries to prove that mankind could only compete with other stronger species by inventing tools—and thereby gaining a great brain in an impossibly short time. As the note-maker implies derisively, why didn't other species of apes invent tools?

The answer is that neither man nor apes invented tools. They were given to us by starmen overseers back in the Paleolithic age some 15,000 years ago!

It is not only Charles Fort and Fred Hoyle who claim we are the property of super-minds. A search through world literature in the past reveals many similar statements. The orthodox establishment today consider them "myths" or superstition.

The Resicrucians, the Vril Society, and others have constantly reiterated that there is a "Master of the World" residing in some remote area like Tibet. Oddly enough, a well-educated college student, who is one of the "ESP contactees," claims to receive messages from "the master" who dwells in Tibet.

The Luminous Lodge is another esoteric society which has dug out data proving, they believe, that a race of beings with vastly powerful psychic powers remains hidden in deep caverns, but in reality "rules the world."

The "Unknown Supermen" are recorded by a dozen secret societies, notably the Thule Group of Germany, as hidden masters who have long held complete sway over earth.

Charles Fort, too, seemed to come to the conclusion that they were on the right track, when he says—"There may be occult things, beings and events, and there may be something of the nature of an occult police force which operates to divert human suspicions (that) they, too, may be exploiting life upon this earth."

Shades of the Men-in-Black! Fort foretold (or saw evidence even in his time) of the strange offshoot mystery of flying saucers today—what beings are suppressing UFO evidence, and why?

Fort expands this further—"I suspect that, after all, we're useful . . and that something now has a legal right to us and that all this has been known, perhaps for ages, to certain ones upon this earth. A cult, or order, members of which function like bell-wethers to the rest of us, or as superior slaves to overseers."

This would fit in remarkably well with how the mysterious harassers of UFO investigators and witnesses operate, keeping the human race "in line" on orders from our owners,

For more up-to-date evidence, look at this case.

On February 21, 1965, a saucer landed at the town of Chalac, on the Argen-90

tine-Paraguayan border in South America. Fifty Indians of the Toba tribe were awed to see three tall man with luminous halos step out and proclaim that nobody need fear them—that they would help earth in various ways. The Indians bowed down in reverence, as this was exactly like the oral traditions of their tribe of "gods" landing in ancient times.

Fanciful imagination by unlettered peasants? Besides the Indians, there were Argentine police officers as witnesses, who took photographs of the machine the beings landed in. These photos were never released, backing up Dr. Hoyle's statement that governments all over earth are suppressing concrete proof of UFOs, And we mean Owners.

Another recent case is that of Herbert Schirmer, a police patrolman. Young, muscular and level-headed, Schirmer was cruising at midnight on December 3, 1967, when a saucer landed and he was invited aboard. Several "little men" 4 1/2 feet tall "interviewed" him and made many statements indicating they "watched over earth" at all times.

The most revealing thing was that Schirmer got a good look at an emblem they wore on their chests—a serpent with wings. This happens to be, in all ancient literature around the world, the symbol of authority. This dragonlike form is rife in old Chinese lore and in Mayan hieroglyphics, as well as the writings of a dozen other ancient civilizations.

Down in Nacza, Peru, there exist giant figures carved on the ground in ancient times—huge circles, ellipses, triangles, also figures of birds, insects, and fish. The pattern can only be seen from the air. Archeologists are at a loss to explain how the ancient people could devise such precise geometrical figures over miles of land without modern surveying tools. Nor why they should make such tremendous patterns that would be visible only from space.

Therein lies the answer, according to certain UFOlogists—they are guideposts for flying saucers coming in from outer space, and secondly, they represent a stamp of ownership. In effect, the symbols mean—OFF LIMITS! DO NOT TRESPASS ON THIS PROPERTY!

The concept of earth-ownership can also explain, for the first time, other enormous structures on earth, including the huge Baalbek temple in Syria, the giant stone heads of Easter Island, the mighty Cheops pyramid of Egypt, the co-Iossal Sacsahuaman fortress in Peru at 12,000 feet altitude in the Andes, the towering Black Pagoda of India with a single stone slab weighing 2,000 tons, and other giant mounds or edifices all over earth. For primitive people with little better than stone-age tools to have carved and constructed such fantastic marvels of engineering, as archaeologists insist, is incredible,

The simplest and most believable explanation is that the alien owners of earth built them, using super-scientific or super-engineering methods. Their reasons? Again we must put it down to the unknown and unknowable.

Another ancient clue to our status as property is the fact that all cultures in the past received a "code of ethics" from some "god" or superior being. Moses and the 10 Commandments is a typical example. If for "Jehovah" we substitute an authoritative man in a flying saucer (the "glowing cloud" on the mountain) we can see how our alien owners again did a beneficent thing and helped elevate human ethics. The Torah's detailed dietary rules supposedly divinely inspired-are even more significant as they show immense knowledge of the human body and its proper foods. The Biblical examples show the innumerable ways in which our alien owners have interceded, guided, changed. planned, and in general manipulated human society down through the ages, as Fred Hoyle said.

An odd thing pointed out by historians of the occult is that it is only in modern times that we have not recognized or believed in visitors from the sky. In ancient times, it was taken for granted.

And if the aliens have experimented and let us run the world ourselves in the 20th century, then assuredly we've botched the job. We may have earned the penalty of being put back under the thumb of our alien overlords.

If this seems a flagrant thing to do—running a whole world and all its people without their "permission"—remember that we probably cannot ever understand the why of their self-appointed missions.

Two theories would make things clear if they were true.

One is that we are an "asylum" world where all the insane people of this universe are confined, and the aliens are our "wardens."

Secondly, that we are the dumping grounds for all the criminals in the cosmos, and the aliens are our "jailers."

However, both of these concepts are too simplistic and "down-to-earth" to be believed. We are merely extending an earthly rationale into space culture where life may be on an entirely different plane.

Still, why do they "rule" us? Here again we are skating dangerously close to an attempted explanation of their motives, but one concept seems to fit very strongly—the aliens actually created us long ago by genetic manipulations, thus making us their "property."

One UFO report among others seems to bear this out quite strikingly. In 1947, in Venezuela, Senor C.A.V. (identity protected) reported a flying saucer landing and contact with strange beings who spoke Spanish. During the course of the long conversation, C.A.V. mentioned "God, the Supreme Creator."

"Well, we are like gods," said one alien and implied that they had created life on earth—all life, including man. They later informed C.A.V. that they were eternal and never died.

Is earth, then, nothing more than a vast "laboratory" to them, in which they perform fantastic "experiments" beyond our comprehension? Are they "mad scientists" toying with a whole world and its helpless people? And what evidence supports the mind-numbing view that the UFOs are here to maintain their ancient property rights over earth and all its creatures? When we further review old and "classic" UFO reports in this new light,

we will find that they can be reinterpreted to ominously fit into the idea of alien-ownership.

One of the statements made by Patrolman Schirmer was—"I think some people have been picked up and their brains have been changed in some way... I am certain that these 'people' could control a man through his brain for as long as they wanted."

This dovetails completely with many MIB (Men-In-Black) cases in which the witness complains of being "controlled" mentally. Also PK-Man Ted Owens (see March and April '71 SAGA) is convinced that the SIs "altered" the right side of his brain.

Many people are familiar with the 1961 case of Barney and Betty Hill who were taken into a saucer in a hypnotized state and given a thorough physical examination, including taking a sample of the man's semen. Then there is the celebrated case of Antonio Villas-Boas who in 1957 was "seduced" by a four-foot female aboard a saucer.

From this clue, one UFO researcher surmised that if only one case out of some 10 to 20 ordinary sightings is never publicly reported (per John Keel) for fear of ridicule, there may be only one out of 100 cases reported which involves sexual contact with the aliens. This follows the thesis that our alien owners not only biologically created us, as human hybrids, but are still carrying on genetic experiments to "improve" us, or at least change us in some way.

What could be a more blatant sign that we are their living property than this program of "breeding stock" experiments all over earth? Yet like many rape victims, these are the cases most likely to be closely guarded personal secrets that even a Charles Fort could never uncover.

Do the UFOwners know this, hence feel safe from being accused and exposed?

How did the Eskimos ever migrate—voluntarily—to the frozen north to

eke out a precarious living in that frigid land? Was it voluntary? Their legends clearly state that a flock of giant "metallic birds" carried their ancestors to the north. Was it another UFOwner experiment, to see how well their created hybrids would thrive under adverse conditions? If so, it's clearly an act of utter authority in which the subjects were never consulted.

Many more strange acts and activities of the aliens in saucer sightings will, if reinterpreted in the light of their ownership of earth, suddenly make sense.

Take the large number of cases where "little men" were seen outside their landed saucers, gathering "samples" of various kinds,

- November 28, 1954 near Caracas, Venezuela, two truck drivers came upon "bellicose" hairy dwarfs who were gathering stones.
- December 19, 1954 also near Caracas, Jose Parra saw six little men pulling up boulders and heaping them in their saucer.
- In 1963, in the State of Parana, Brazil witnesses saw three UFOnauts, this time normal-sized human-like beings, walking around and picking up burnt material after a forest fire, also charred stones.

There is a long list of similar cases but why would the UFOnauts collect stones, of all worthless things? We run into the unknowable syndrome again, but we can hazard a guess that might not be far wrong. On the moon, our astronauts set up an aluminum sheet for several hours, which they later brought back to earth. This sheet revealed how many protons and electrons had bombarded it on the moon and embedded themselves in the metal.

Do common stones on earth act as similar "solar radiation" detectors? Is that why the UFOwners constantly collect them, year in and year out, all around the world? And remember, if earth is their property, they would keep constant watch on all conditions on its surface to see that the "norm" prevailed.

Another category of sightings and samples is closer to home.

- December 11, 1954 near Linda Bela Vista, Brazil, a farmer saw two human-like beings pick up a tobacco plant and a live chicken.
- December 29, 1954 near Gardonne, France, the witness saw a round orange saucer leap from the ground. He then found the ground there dug up, and small trees that were cut up.

 November 4, 1954, while fishing on the Pardo River, near Pardal, Brazil, Jose Alves saw three "little men" gathering samples of grass, herbs, and tree leaves.

That list also goes on and on, where the UFOwners gathered specimens plants and an occasional animals. Now here one need hardly guess that our alien proprietors are keeping close watch on all of earth's vegetation and animal resources.

One of the most arresting facets of the UFO phenomenon is a growing list of cases where animals are "dissected" and left lying. The corpses of cows, dogs, horses, and other domesticated animals often have been found, usually after a saucer sighting in the vicinity, with their vital organs removed. In the case of one horse, all the skin of his head had been neatly removed.

Still more baffling, animal carcasses have been found butchered with the phosphorous of the bones removed. How anyone could chemically extract phosphorous in a short time, without disturbing the rest of the bone matter, is almost unbelievable.

But as the noted writer Arthur Clarke put it—"Any manifestations of the science of a race far ahead of us would seem like sheer magic." In short, unbelievable.

Another numerous group of sightings might also indicate that our UFOwners were keeping tabs on our water supply, or its purity.

- May 20, 1953, near Brush Creek, Calif., two miner-prospectors witnessed a "little man" jumping out of a saucer and scooping up a pail of water to be taken away.
- During the spring of 1960 near Syracuse, N.Y., Mr. X, while fishing at dusk saw a flying disc land in the river, whereupon three tiny men hauled out hoses and pumped water into their craft.
- All during 1965 at Wanaque Dam, N.J., UFOs were seen by hundreds of people. In some cases they hovered over the water and beamed down light rays that melted ice in the dead of winter.

Surely, in the above cases, the UFO-nauts would hardly need the water for drinking or other purposes. It would not be pure or potable water. It looks much more like sample-taking of different types at different spots, for testing purposes. Testing for what? Disease? Germs? Poisons? Deleterious impurities? But the very act of their continuously scooping up water makes it a routine operation such as property-owners would make on any ranch or farm.

Are the UFOwners, realizing that water is vital to earthly life, keeping check on it? If so, why aren't they doing something about growing water pollution? Or are they going to do something about it soon, after they analyze their water samples? We can strongly surmise that if earth is

their property, they are hardly going to let this planet become polluted, destroying their human property too. And if we weren't useful alive, they would have wiped us out long ago.

So the idea of UFOwners is not all heart chilling. We can take some comfort in the thought of them wanting a "viable" and livable earth as much as we do.

That the UFOwners also experiment with the human nervous system seems hardly questionable from the following cases:

- December 19, 1954, in Valencia, Venezuela a man saw six small creatures walking out of a landed saucer. He tried to turn and run but was "paralyzed" by a violet light-beam one of them aimed at him.
- October 11, 1954, near Corbigny, France two men were driving when they came upon a landed saucer in a field. Two "little men" stepped out and a red glow paralyzed the witnesses leaving them unable to move a muscle.
- October 26, 1954, in La Madiere, France, a farmer was confronted by a human-like figure who beamed twin blue lights at him, which knocked him over.

There are plenty of such cases to indicate a standard "procedure" followed by the UFOwners, which might be a test of human nervous reactions to see whether the physiological status quo of their "human farm" on earth is unchanged. But then again it might be some esoteric experiment whose objective could never be grasped by our earthbound minds.

Certainly, it is not of harmful intent. Not one of the witnesses was killed or even hurt—just badly scared. In some cases, there were aftereffects of sore muscles, nausea, and tingling skin but nothing more serious.

This further proves there is little if any UFO hostility toward us, preparatory to "invading earth." The picture keeps looking more and more like resident owners who have long strolled among their human subjects and "tested" them in various ways for whatever "biological log" they keep.

A new look at many UFO cases reveals what can only be interpreted as "acts of ownership" by our alien keepers.

Officer Herbert Schirmer comes into the picture again. Recounting his experience, Schirmer said he was invited aboard the saucer and during a flight, the craft hovered over an electric power line. Schirmer then described what his alien host did: "He pushed a button. I saw an antenna-like thing move down and around to where it pointed at the power line... there was a sudden white spurt of electricity. It shot out of the electrical line and went right into the top of the antenna." The alien then showed Schirmer his gauges, which indicated a full power load taken from the power lines.

Many saucers have been seen hovering over power lines, as if "sucking up" electricity. And this might very well explain the increasing reports of power blackouts around the world. The fact that 23 saucers were seen hovering over parts of the electrical grid system may well explain the Great Northeast Blackout of the eastern states and Canada, in November 1965. In short, the UFOs drew too much power out of the cables and left eight states and 30

million people without electricity. Rather than a "hostile" act, or a "test" of how to quickly render civilization helpless when they attacked, this is more likely an error on their part-extracting too many kilowatts from the power grid.

What they need the electricity for is anybody's guess, but such power blackouts, small and large, afflicting cities all around the world regularly, gives the impression of them not borrowing but simply taking what-in their eyes-is rightfully theirs. If they own earth, they own everything on it, natural or man-made,

This brings us to a grimmer side of the whole mystery-UFO kidnapers. Each year it is estimated that some 100,000 people literally vanish off the face of the

earth.

Perhaps one case gives us the clue. On August 26, 1967, at Maiwietia, Venezuela, a marine guard had just come off duty at the airport. He encountered a three-foot tall being with an enormous head who said clearly, "Won't you come with me? We need one human." The marine fainted and woke up to find the creature gone.

There are eyewitness cases of people vanishing before their eyes—a boy in South America saw his father enveloped in two yellow balls of vapor to never reappear again; a farmer in America saw his son "levitated" into the air up to a flying saucer; a whole regiment of soldiers in WW I apparently marched into a lowlying cloud in front of 100 witnesses and never marched out of it.

Nobody has solved the wholesale disappearance of the Easter Islanders who built (with alien help) those giant stone heads. In November 1930, a trapper in the Canadian north entered an Eskimo village and found not a soul. Nothing was disturbed or stolen, there were no signs of a battle, and everything was intact. But over 50 Eskimos and their dogs were missîng.

And what's behind the many marine mysteries such as Mary Celeste where every member of the crew and passengers disappeared? Time after time ships are found abandoned on the high seas, without the slightest clue as to how the people aboard could have just vanished.

We need not go into the story of missing planes and ships as this has been spelled

out in detail many times.

At any rate, it is a fact that all through history, people have been vanishing at a grim rate for which there is no rational explanation. The accumulated millions of people through the ages could not have vanished without a trace-unless somebody took them away.

Actually, the only thing that really explains this riddle is that we are "property" and our alien owners simply snatch specimens as they please, for what purpose we cannot imagine,

One of the notes in Jessup's book, in the "Allende Case," was in answer to Jessup's question regarding missing people and what happened to them. The alien's brief and flesh-crawling notation was-"Heh! If he only knew, he'd die of

Another variant of flying saucer behavior seems to clearly show that we are constantly being observed or "evaluated" or "tested" by our masters—the large body 94 🖂 SAGA

of cases where UFOs chase cars, planes, trains, and individuals.

Cars have often suddenly stalled while a saucer hovered or circled above as if examining the passengers like bugs under a microscope. Planes have been pursued for miles by cavorting UFOs that flew rings around them. Trains and ships at sea have also been harassed by low-flying sau-

If one multiplies today's known cases by a factor of 10 or 20 to allow for unreported incidents, and expands this to include the past, we get the uneasy conviction that mankind has been under "surveillance" through history. It is not spy surveillance to find out our military defenses, but a patrol of a world the "ownconquered long ago.

Or, it is like a scientific survey of a vast planetary "laboratory" in which all kinds of experiments are being conducted.

What lends credence to this thought is another great mystery that Charles Fort first exposed—sky-falls.

The most incredible things fall from the sky. Millions of frogs, fish, newts, and snails have dropped from the heavens. Fort actually listed 294 species of this "living" rain. Weak attempts to explain them as being "dropped by tomadoes' usually fell flat when the weather bureau staunchly denied any such tornado occurred or could occur.

Ivan Sanderson in his book Uninvited Visitors, gives the elaborate and wholly logical explanation that the aliens have giant ships in the upper atmosphere which produce food by hydroponic methods (soilless plant cultures) and in tanks wherein small animals are artifically grown.

This seems verified by another Allende note in Jessup's book, where he too speculates that the aliens may be hydroponic "farming" aboard their huge craft. The alien's succinct notation is—"On the head!"

But the jackpot is hit when Jessup's text wonders why there are sky-falls of small creatures, living tissue, and even raw meat. The brief but illuminating notation-"Spoiled food, dropped."

Besides this, just about anything you could name has fallen from the sky including strange stones, coal, flowers, ice, grains, glass, silver, sulfur, and salt.

There can be no logical answer to all this, except one—that huge flying laboratories exist above our world, from which they periodically dump unwanted materials, both inanimate and living. It is on record via Charles Fort that flesh and blood have also fallen from the sky many

Add to this a long list of mysterious sounds from the sky-usually loud explosions or long rumblings-without any discernible source. Since these sky-noises have been recorded for centuries, they all cannot be explained away as modern-day sonic booms or rocket blasts. Do these sounds come from great aerial labs circling earth?

After pondering all the implications of earth being a planet-sized bio-lab for the aliens, Ivan Sanderson comes up with the thought-provoking suggestion that our world may be a "cosmic nursery" in which we are only the "larvae" for a more advanced race of humans, who might even be

biocybernetic beings with computer brains. Whether he has touched on the true scheme of the aliens, or whether that is still utterly beyond our groping minds, is difficult to say.

At any rate, we may soon find out if Dr. Fred Hoyle is right.

At the end of his press conference, he said that his scientific colleagues agreed that enough of this information must be divulged to the public to soften the shock when the full revelation came, and that "A little at a time, more facts will be released (by us) until everyone has access to all the information which is now only in the hands of scientists and government officials."

He clarifies the aliens somewhat more by adding, "It is not an alien intelligence from another planet. It is actually from another universe which entered ours at the very beginning and has been controlling all that happened since."

The late famed psychiatrist Dr. Carl Jung, thought along the same lines when in his book about saucers he wrote that the possible physical existence-namely, the reality-of UFOs seemed so significant that he felt compelled to "sound a note of warning.

He went on to say that his conscience compelled him to fulfill his duty and "prepare those few who will hear me for coming events which are in accord with the end of an era."

He goes on: "As we know from ancient Egyptian history, there are symptoms of psychic changes that always appear at the end of one Platonic month (an extremely long time) and at the beginning of anoth-

Now here, Jung brings in his concept of the "collective consciousness" which he believed accounted for all psychic or paranormal phenomena,

Jung's collective consciousness could be exactly what Fred Hoyle talks about when he says our whole life is controlled. "by these creatures with fantastic mental powers."

Jung did not suspect the presence of alien owners, but he did sense that something was working on the collective human mind: "There are, it seems, variations in the constellation of psychic dominants, of the archetypes, or 'gods' as they used to be called, which bring about long lasting transformations of the collective psyche.

His concluding words were, "I am, to be quite frank, concerned for all those who are caught unprepared by the events in question and disconcerted by their incomprehensible nature.'

Doesn't that sum up the whole UFO mystery in a nutshell? First, that "psychic changes" are coming, followed by the "end of an era," which will include revelations of an "incomprehensible nature." Jung, a psychic sensitive himself. seemingly had a flash of insight into the fact that all humanity was in the hands of an outside band of intelligent forces.

But Charles Fort, long before the term "flying saucers" was known, had the first great glimpse into the unknown by his simple words—We are property.
